Authorizing the City Manager to enter into Amendment No. 1 to the contract with OMAC Hauling, Inc. for nuisance abatement services as needed by the City, to increase the contract in an amount not to exceed \$40,000.00 for a total amount not to exceed \$90,000.00.

WHEREAS, pursuant to Ordinance No. 24-266, the City entered into a contract for nuisance abatement services as needed by the City with OMAC Hauling, Inc.; and

WHEREAS, it is necessary to increase the contract in an amount not to exceed \$40,000.00 for a total amount not to exceed \$90,000.00, in order to continue the abatement of nuisance conditions in the City; NOW, THEREFORE:

BE IT ORDAINED by the City Commission of The City of Springfield, Ohio:

Section 1. That the City Manager is hereby authorized to enter into Amendment No. 1 to the contract with OMAC Hauling, Inc. for nuisance abatement services as needed by the City, to increase the contract in an amount not to exceed \$40,000.00 for a total amount not to exceed \$90,000.00.

Section 2. That this Ordinance shall take effect and be in force from and after fourteen (14) days from the date of its passage.

AMENDMENT NO. 1
OMAC Hauling, Inc.

This Amendment No. 1 is entered into by and between the City of Springfield, Ohio ("City") and OMAC Hauling Inc. ("Contractor"), and is intended to amend the original contract executed between the parties.

RECITALS

- a. The City and Contractor entered into contract on September 27, 2024 for nuisance abatement services, with a Not-to-Exceed (NTE) amount of \$50,000.00.
- b. The Parties now desire to amend the Agreement to increase the NTE amount by \$40,000.00.
- c. All other terms and conditions of the original Contract remain unchanged and in full force and effect.

AGREEMENT

1. Amendment to Section 3 – Compensation

The total Not-to-Exceed (NTE) amount under the Agreement is hereby increased by **Forty Thousand Dollars (\$40,000.00)**. The revised total NTE amount shall be **Ninety Thousand Dollars (\$90,000.00)**.

2. No Other Changes

All other provisions of the Contract, including the Contract Documents incorporated therein, remain unchanged and in full force and effect.
